All Mutton Bustin' participants must be under 60 lbs. and at least 4 years old.

My child plans to participate in the Mutton Bustin' activities. I request that my child be permitted to participate in the activities. I agree to be present at the event and to supervise my child prior to participating in and during the event. I understand I must provide any protective gear I deem appropriated for my child. I understand that if I am not present, my child will not be allowed to participate in the event, I understand that physical contact with sheep, or being on or around sheep can be dangerous to my child and myself and could result in serious injury to my child or me.

I for on behalf of myself and my child being fully aware of the risks involved in the activity of Mutton Bustin', **I HEREBY RELEASE/WAIVE ANY CLAIM AND CAUSE OF ACTION** against the Arkansas Valley Exposition & Fair Association and its subsidiaries, affiliates, officers, directors, employees, members, agents participants, sponsors, representatives, sanctioned entities, advertisers and anyone else involved in the event, collectively referred to as the "releases".

I FURTHER HOLD THE "RELEASES" HARMLESS AND RELEASE THE "RELEASES" FROM ALL LIABILITY to my child, to me, my spouse, my personal representatives, assigns, heirs and next of kin for any and all loss or damage and any claim or demand on account of any injury to the participant including, but not limited to, death whether caused by the negligence of the "Releases" or otherwise while I am in or upon the restricted and/or competing, observing, working for any purpose participating in the event.
